The Nordic Culture Fund has now processed your funding application. Based on an overall assessment of the applications it has received, the fund has decided that the application can not be prioritized.

The Fund's assessment of your application is:

the project presents an interesting vision for developing a Nordic version of IYMS - a Nordic Youth Media Summit, but the content of the proposed project is inadequately described: the project plan does not adequately support the project's ambitions and Nordic collaboration.
